**Traveling from Lexington:** South on I-75 take Richmond exit 90A onto US25S/US421S (Robert R. Martin Bypass), proceed to the 3<sup>rd</sup> Stop Light #15, Turn Left onto State Road 1986 N, proceed to the next Stop Sign Turn Left onto Red House Road State Road 388N. Arena is on the Right approximately 1 mile, Turn in at the White Board Fence entrance.

**Traveling from London:** North on I-75 take Richmond exit 90 onto US25S/US421S (Robert R. Martin Bypass), proceed to the 2<sup>nd</sup> Stop Light #15, Turn Left onto State Road 1986 N, proceed to the next Stop Sign Turn Left onto Red House Road State Road 388N. Arena is on the Right approximately 1 mile, Turn in at the White Board Fence entrance.
